2014 RESOLUTION APPOINTMENT

EMERGENCY MEDICAL DISPATCHER/TELECOMMUNICATOR - CICCONE

WHEREAS, a vacancy exists in the Bloomfield Police Department in the position of Emergency Medical Dispatcher/Telecommunicator; and

WHEREAS, Officer in Charge Captain Wiegand has recommended hiring an Emergency Medical Dispatcher/Telecommunicator; and

WHEREAS, Officer in Charge Captain Wiegand recommends that Alexandra Ciccone be appointed to the position of Emergency Medical Dispatcher/Telecommunicator effective April 8, 2014; and

WHEREAS, the Director of Finance has certified that funding is available for this position in the Police Department Budget.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Alexandra Ciccone is hereby appointed to the position of Emergency Medical Dispatcher/Telecommunicator for the Bloomfield Police Department, effective April 8, 2014, at the annual salary for step 1 in effect for such position.

BE IT FURTHER RESOLVED, that this appointment is subject to the Bloomfield Township Town Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield and to maintain such a residency and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharged from employment.
