2014 RESOLUTION AWARD OF PROFESSIONAL SERVICE

VARIOUS IMPROVEMENTS TO TOWNSHIP FACILITIES

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on March 19, 2014 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for Various Improvements To Township Facilities; and

WHEREAS, a total of three (3) bids were received and were referred to the Township Engineer for review; and

WHEREAS, two of the bidders requested that their bids be withdrawn due to misinterpretation of the bid documents and project scope; and

WHEREAS, Tec Con Contractors, Inc., 9 Dodd Street, East Orange, New Jersey 07017 provided the lowest bid when combining all three projects which are the reconstruction of the steps, ramps and entrance to the Law Enforcement Building; reconstruction of the Civic Center front and side steps and reconstruction of the Civic Center front balcony; and

WHEREAS, the total contract price provided by Tec Con Contractors, Inc., to perform all three projects is \$248,055.00; and

WHEREAS, after review of the bids, the Township Engineer hereby recommends that the contract be awarded to Tec Con Contractors, Inc., 9 Dodd Street, East Orange, New Jersey 07017 in the amount of \$248,055.00; and

WHEREAS, the Director of Finance has indicated that funding is available within Township Capital Account #C-04-55-864-947.
