2014 RESOLUTION AGREEMENTS

TONNAGE GRANT APPLICATION

WHEREAS, the Mandatory Source Separation and Recycling Act, P.L.1987,c.102, has established a recycling fund from which a tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, it is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use tonnage grants to develop, continue and expand municipal recycling programs; and

WHEREAS, the New Jersey Department of Environment Protection has promulgated recycling regulations to implement the Mandatory Source Separation and Recycling Act; and

WHEREAS, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, a resolution authorizing the Township of Bloomfield to apply for such tonnage grants will memorialize the commitment of the Township of Bloomfield to recycling and to indicate the assent of the Mayor and Council to the efforts undertaken by the Township of Bloomfield and the requirements contained in the Recycling Act and recycling regulations; and

WHEREAS, such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby endorses the submission of a recycling tonnage grant application to the New Jersey Department of Environmental Protection

and designates Joe Testa Recycling Coordinator, to ensure that the application is properly filed;
and

BE IT FURTHER RESOLVED, that the monies received from the recycling tonnage grant be deposited in a dedicated recycling trust fund to be used solely for the purposes or recycling.
