**RESOLUTION AUTHORIZATIONS FOR THE EXECUTION OF AN APPLICATION FOR A NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION TREATMENT WORKS APPROVAL - HERITAGE VILLAGE AT BLOOMFIELD - 390 FRANKLIN STREET, BLOCK 311, LOT 13**

**WHEREAS**, The Bloomfield Parking Authority, 230 Broad Street, Bloomfield, N.J. 07003 hereafter referred to as "the Applicant" is proposing the construction of a development comprised of residential apartments, as well as 20 linear feet of 8-inch diameter sanitary sewer; and

**WHEREAS**, this development will require the submission of a Treatment Works Approval Application to the New Jersey Department of Environmental Protection; and

**WHEREAS**, a Treatment Works Approval application requires execution of a Statement of Consent (Form WQM-003) by the governing body in which the project is located which is the Township of Bloomfield; and

**WHEREAS**, the plans and application materials were reviewed and approved by the Township Engineer and were found to be acceptable.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Township Council that the Mayor of the Township of Bloomfield is hereby authorized to execute the Statement of Consent (Form WQM-003) and any other required documents for submission of a New Jersey Department of Environmental Protection Treatment Works Approval for the redevelopment of Block 311, Lot 13 in the Township of Bloomfield.
