2014 RESOLUTION AWARD OF CONTRACT

MAINTENANCE OF TOWNSHIP-OWNED UNDERGROUND STORAGE TANKS (UST'S)

WHEREAS, the Township of Bloomfield requires the services of a firm to inspect, repair and maintain the various Township-Owned Underground Storage Tanks (UST's); and

WHEREAS, the annual cost of this work is expected to exceed \$17,500.00; and

WHEREAS, in accordance to N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" the Township can award the services of a firm that possess a New Jersey State Contact without needing to publicly bid the work; and

WHEREAS, Independence Constructors, Inc., 1200 Route 22, Bridgewater, New Jersey 08807 are in possession of State Contract Number A75553 for UST Maintenance Services at a cost of \$1,884.00 per month; and

WHEREAS, after a favorable review of the qualifications of the firm, the Township Engineer recommends that a one-year contract be awarded to Independence Constructors, Inc., 1200 Route 22, Bridgewater, New Jersey 08807 at the prices indicated in state contract number A75553 ; and

WHEREAS, the Director of Finance has indicated that funding is available in Township Account Numbers 4-01-26-772-024 & 4-01-31-820-074.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the Maintenance of Township-Owned Underground Storage Tanks with Independence Constructors, Inc., 1200 Route 22, Bridgewater, New Jersey 08807 at the prices and percentages indicated in N.J. State
