2014 RESOLUTION CHANGE ORDERS

**BUKOWSKI PLACE AND JOHNSON AVENUE SANITARY SEWER REPLACEMENT
- CHANGE ORDER NO. 1 – FINAL**

WHEREAS, the Township of Bloomfield entered into a contract for the Bukowski Place and Johnson Avenue Sanitary Sewer Replacement with Shauger Property Services, Inc., 429 Dodd Street, East Orange, New Jersey 07017 in the amount of \$130,815.00; and

WHEREAS, during the course of the project, it was necessary to adjust or modify the amount of construction items to account for unforeseen site conditions; and

WHEREAS, the Township Engineer has reviewed the changes enumerated in Change Order No. 1 - Final and recommends the Change Order be approved; and

WHEREAS, Change order No. 1- Final represents an increase in \$2,759.00 to the original contract price of \$130,815.00 for a total increase of 2.1%; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the specified changes should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Township Sewer Capital Account No. C-04-55-919-986.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1- Final is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
