2014 RESOLUTION CHANGE ORDERS

AWARD OF CONTRACT - MONTGOMERY STREET & JFK DRIVE INTERSECTION IMPROVEMENTS

WHEREAS, the Township of Bloomfield entered into a contract for the Montgomery Street & JFK Drive Intersection Improvements with Fai-Gon Electric, Inc., 140 Eleventh Street, Piscataway, NJ 08854 for a total contract cost of \$451,693.90; and

WHEREAS, during the course of the project, it was necessary to adjust or modify the amount of construction items to account for unforeseen site conditions; and

WHEREAS, the Township Engineer has reviewed the changes enumerated in Change Order No. 1 - Final and recommends the Change Order be approved; and

WHEREAS, Change order No. 1- Final represents an decrease in the cost of the contract in the amount of \$51,228.71 and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the specified changes should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Township Account C-04-55-850-965 and is reimbursable through a grant from the New Jersey Department of Transportation Trust Fund.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1- Final is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
