2014 RESOLUTION APPOINTMENT

APPOINTMENT JUDGE PIRONE

BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield that pursuant to and in accordance with N.J.S.A. 2B:12-4 that the following appointment is hereby made to the Municipal Court of the Township of Bloomfield, New Jersey, for a term beginning May 6, 2014 and ending May 5, 2017 (three years as required by statute) at the respective annual salary for such position provided in the general salary ordinance of the Township of Bloomfield

BE IT FURTHER RESOLVED, that Judge Pirone has agreed to waive any and all rights to receive health, prescription and dental benefits from the Township of Bloomfield; and

BE IT FURTHER RESOLVED, that Judge Pirone recognizes that the Township is in the process of reducing the salary guide for this position and accepts the position with full knowledge of the reduced salary; and

BE IT FURTHER RESOLVED, that the Township recognizes a Judge's salary should not under normal circumstances be reduced during the Judge's term, however, Judge Pirone has requested that this resolution be past while salary is adjusted and indicated his acceptance of the new reduced salary; and

BE IT FURTHER RESOLVED, that as an accommodation to Judge Pirone, instead of waiting until the salary ordinance is finalized, the Township has agreed to consider this
