**2014 RESOLUTION APPOINTMENT**

**PART-TIME PROVISIONAL PLUMBING OFFICIAL**

**WHEREAS**, on Monday, January 13, 2014, the Mayor and Council passed a resolution appointing Rocco Ciufalo as part-time temporary plumbing official ending April 15, 2014; and

**WHEREAS**, a vacancy still exists in the Township of Bloomfield Inspections Department for the position of part-time provisional plumbing official; and

**WHEREAS**, the Director of Community Development and Inspections recommends hiring Rocco Ciufalo to the position of part-time provisional plumbing official; and

**WHEREAS**, Rocco Ciufalo recognizes that he will not receive health benefits and the work is a minimum 20 working hours and a maximum of 25 working hours; and

**WHEREAS**, the Finance Director has certified that funds are available to make this part-time appointment.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Rocco Ciufalo is hereby appointed to the position of part-time provisional plumbing official at a rate of \$30.00 per hour effective immediately subject to the terms of this resolution; and

**BE IT FURTHER RESOLVED**, that Mr. Ciufalo's employment with the Township automatically terminate once the Council appoints a permanent Plumbing Sub-Code Official from a Certified list of eligible for hire currently being prepared by Civil Service
