2014 RESOLUTION APPOINTMENT

PART-TIME PROVISIONAL ELECTRICAL SUB-CODE OFFICIAL

WHEREAS, on Monday, January 13, 2014, the Mayor and Council passed a resolution appointing Robert Lynch as part-time temporary electrical sub-code official ending April 15, 2014; and

WHEREAS, a vacancy still exists in the Township of Bloomfield Inspections Department for the position of part-time provisional electrical sub-code official; and

WHEREAS, the Director of Community Development and Inspections recommends hiring Robert Lynch to the position of part-time provisional electrical sub-code official; and

WHEREAS, Robert Lynch recognizes that he will not receive health benefits and the work week is a minimum 20 working hours and a maximum of 25 working hours; and

WHEREAS, the Finance Director has certified that funds are available to make this part-time appointment.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Robert Lynch is hereby appointed to the position of part-time provisional electrical sub-code official at a rate of \$40.00 per hour effective immediately subject to the terms of this resolution; and

BE IT FURTHER RESOLVED, that Mr. Lynch's employment with the Township will automatically terminate once the Council appoints a permanent Electrical Sub-Code Official from a Certified list of eligibles for hire currently being prepared by Civil Service
