2014 RESOLUTION GRANT AGREEMENTS

APPROVAL TO SUBMIT A GRANT APPLICATION AND EXECUTE A GRANT AGREEMENT WITH THE NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR THE 2014 TRANSPORTATION ALTERNATIVE PROGRAM FOR THE TOWNSHIP OF BLOOMFIELD LACKAWANNA TRANSIT STATION IMPROVEMENT PROJECT

WHEREAS, the Township of Bloomfield continues to develop projects that will improve the accessibility, use and maintenance of Lackawanna Transit Station; and

WHEREAS, the Township of Bloomfield's Engineering Department has provided plans specifically designed to address and improve accessibility, traffic flow, safety issues and the condition of the curbs and sidewalks immediately surrounding Lackawanna Transit Station; and

WHEREAS, the Township of Bloomfield has designed the Lackawanna Transit Station Improvement Project for streetscape, signage and safety improvements at Lackawanna Transit Station; and

WHEREAS, the Township of Bloomfield through its Department of Public Works and Parks will assume all responsibility with regard to the maintenance and upkeep of this project; and

WHEREAS, the Township of Bloomfield will assign Paul Lasek, Township Engineer, to serve as the *responsible charge* for the project.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, in the County of Essex, State of New Jersey formally approves the grant application for the Lackawanna Transit Station Improvement Project; and

BE IT FURTHER RESOLVED, that the Mayor and Clerk are hereby authorized to submit an electronic grant application identified as *TA-2014-Bloomfield Town Township-00124* to the New Jersey Department of Transportation.
