**AWARD OF CONTRACT - 2011-2012 CAPITAL & CDBG ROADWAY PROGRAM
(CONTRACT 2)**

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on April 23, 2014 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the 2011 - 2012 Capital & CDBG Roadway Program (Contract 2); and

WHEREAS, a total of six (6) bids were received and were referred to the Township Engineer for review; and

WHEREAS, the responsive, low bidder was DLS Contracting, Inc., 633 Franklin Avenue, Suite 170, Nutley, New Jersey 07110 in the amount of \$685,300.25; and

WHEREAS, the Director of Finance has indicated that funding is available in the Township's Capital Roadway Program Account Numbers B-19-12-389-028 and C-04-55-862-966.
