2014 RESOLUTION AUTHORIZATIONS

2014 RESOLUTION ACCEPTING AND AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO NEGOTIATE FOR THE PURCHASE OF AN ADDITIONAL 0.59 MILLION GALLONS PER DAY (MGD) OF WATER SUPPLY FROM THE NORTH JERSEY DISTRICT WATER SUPPLY COMMISSION (NJDWSC)

WHEREAS, on April 11, 2014 the North Jersey District Water Supply Commission, One F.A. Orechio Drive, Wanaque, New Jersey 07455, of which Bloomfield Township is a member, offered the Township an additional water supply allotment of 0.59 million gallons per day of potable water supply; and

WHEREAS, the Township of Bloomfield is in need of additional allotment in order to facilitate continued redevelopment and meet the requirements of the Memorandum of Agreement (MOA) that the Township has with the New Jersey Department of Environmental Protection; and

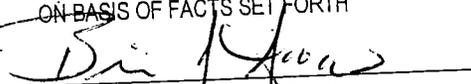
WHEREAS, the additional allotment will increase the Township's current allotment of 6.53 million gallons per day to 7.12 million gallons per day; and

WHEREAS, it is the recommendation of Township Engineer, that the Township actively seek acquisition of the additional water supply and enter into a permanent agreement with the NJDWSC for the additional allotment; and

WHEREAS, obtaining the additional allotment will be beneficial to the Township.

NOW, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that the Township Administrator, or his or her designee, is hereby authorized to accept and negotiate a permanent agreement with the North Jersey District Water Supply Commission for an additional daily water supply allotment of 0.59 Million Gallons per Day (MGD); and
