2014 RESOLUTION AGREEMENTS

INTERLOCAL SERVICE AGREEMENT BETWEEN THE TOWNSHIP OF BLOOMFIELD AND THE COUNTY OF ESSEX

WHEREAS, there is a need for the County of Essex to have an agency provide leaf collection along County roads within the Township of Bloomfield during 2014; and

WHEREAS there is a need for the Township of Bloomfield for road salt during the winter of 2014-2015; and

WHEREAS, the Mayor and Council of the Township of Bloomfield have recommended that an Interlocal Agreement with the County of Essex would be the best method of fulfilling the needs of both parties.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby by authorized the Mayor or Township Administrator to execute an Interlocal Service Agreement with the County of Essex to provide leaf collection by the Township of Bloomfield for the County of Essex along County roads within the Township of Bloomfield during the 2014, in consideration of the County of Essex providing up to 300 tons of road salt to the Township of Bloomfield as requested by the Township during the Winter of 2014 - 2015; and

BE IT FURTHER RESOLVED, that a certified copy of this resolution be sent to the County Director of Public Works.
