2014 RESOLUTION AWARD OF CONTRACT

WHEREAS, all bids were referred to the Township Engineer, Director of Public Works and Parks and the Township Administrator; and

WHEREAS, after due consideration to each of the bids submitted, it is the recommendation that the bid be awarded to Stanziale Construction, LLC, P.O. Box 2597, Bloomfield, New Jersey 07003 in the amount of \$1,920.00 per day for a contract duration of one calendar year; and

WHEREAS, the Director of Finance has indicated that funding is available within the operating budget of the Department of Public Works and Parks.
