**2014 POLICE COMMENDATION - OFFICER STEFANO BARILLARI**

**WHEREAS**, Officer Stefano Barillari is a Police Officer for the Township of Bloomfield; and

**WHEREAS**, on May 14, 2014 at 10:53 am, he was on routine patrol on John Street in the Township of Bloomfield; and

**WHEREAS**, Officer Barillari observed an open door of a residence on that street immediately recognizing that something may be wrong; and

**WHEREAS**, Officer Barillari stopped his patrol car and backed up to investigate, allowing him to hear the faint whimper of a child; and

**WHEREAS**, Officer Barillari exited his patrol car to follow the sounds of the child, leading him to an adjoining yard from the house with the open door; and

**WHEREAS**, Officer Barillari located an 18 month old child, trapped in a manmade fish pond, submerged up to his chest in water, after the child had wandered away from his home and fallen into the pond; and

**WHEREAS**, Officer Barillari was able to rescue the child from the pond, effectively avoiding a certain tragedy; and

**WHEREAS**, Officer Barillari was able to reunite the child with his mother and grandparents happy, healthy and uninjured
