2014 RESOLUTION CHAPTER 159

PROVIDING FOR THE INSERTION OF SPECIAL ITEMS OF REVENUE AND APPROPRIATION IN THE BUDGET CHAPTER 159/4

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of any items of appropriation for equal amount; and

WHEREAS, after the 2014 budget was adopted, the Township of Bloomfield became informed of the availability of revenue in the amount of \$84,704.00 from FEMA and the Department of Homeland Security Assistance to Firefighters along with matching funds in the amount of \$9,411.00 - Account # 4-01-08-329-056.

NOW, THEREFORE, BE IT RESOLVED, that the Township of Bloomfield hereby requests the Director of the Division of Local Government Services approve the insertion of an item of revenue in the Budget of the year 2014 in the sum of \$84,704.00 as an anticipated revenue from FEMA and the Department of Homeland Security Assistance to Firefighters Grant Account # 4-01-08-329-056; and

BE IT FURTHER RESOLVED, that \$84,704.000 is hereby appropriated under the Budget of the Township of Bloomfield for FY 2014 Assistance to Firefighters Grant- Account #4-01-40-340-000; and

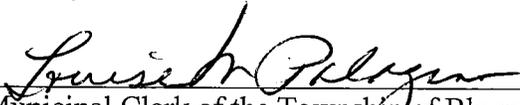
BE IT FURTHER RESOLVED, that this resolution will be filed with the Director of the Division of Local Government Services, Department of Community Affairs.

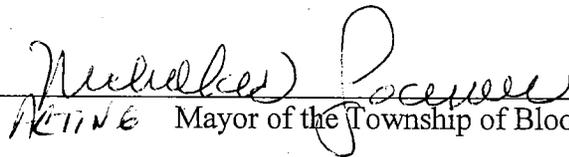
