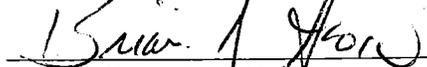
**WHEREAS**, the Township of Bloomfield, Office of Emergency Management has been awarded Emergency Management Agency Assistance Subgrant Program ("EMAA") from the New Jersey State Police Office of Emergency Management Agency available for successful applicants funded through the FY2013 Emergency Management Performance Grant for the dates of July 1, 2013 through June 30, 2014; and

**WHEREAS**, the Subgrant consisting of a total amount of \$10,000 (including \$5,000 Federal Award and \$5,000 Local Matching Funds which the Bloomfield Office of Emergency Management will satisfy with the Office of Emergency Management existing salaries and wages.
