2014 AUTHORIZING RESOLUTION FOR THE EXECUTION OF AN APPLICATION TO CONSTRUCT/MODIFY/OPERATE PUBLIC WATER WORKS FACILITY FOR BLOCK 311, LOT 13, HERITAGE VILLAGE AT BLOOMFIELD - WATERMAIN EXTENSION

WHEREAS, CME Associates, on behalf of the developer Heritage Village at Bloomfield, LLC hereafter referred to as "the Applicant" is making an application to the New Jersey Department of Environmental Protection (NJDEP), Division of Water Supply & Geoscience to modify the Bloomfield water system through construction of a watermain extension related to the construction of a seventy-four unit, residential development at Franklin Street and Municipal Plaza, also known as block 311, Lot 13 on the Bloomfield Township Tax Maps; and

WHEREAS, this modification requires that the Applicant file an application for a permit to construct/modify/operate public water works facility with the NJDEP; and

WHEREAS, this application requires a certification by a representative or representatives of the Township of Bloomfield under sections 6 and 7 of NJDEP Form BWSE-APPLICATION PA 01; and

WHEREAS, the plans and application materials were reviewed and approved by the Township Engineer and Township Water Operator and were found to be acceptable.

NOW BE IT RESOLVED, by the Mayor and Township Council of the Township of Bloomfield, County of Essex, State of New Jersey, that the Township Engineer is hereby authorized to execute form BWSE-APPLICATION PA 01 under Section 6 and the appointed Township Water Operator is hereby authorized to execute form BWSE-APPLICATION PA 01 under section 7.
