2014 ACTION ITEM APPROVAL

AWARD OF CONTRACT - 2014 SIDEWALK REPAIR PROGRAM

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on June 18, 2014 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the 2014 Sidewalk Repair Program; and

WHEREAS, the bids received were referred to the Township Engineer for review; and

WHEREAS, after review of the bids it was determined that the low bidder was S. Batata Construction, 238 Ernston Road, Suite 1R, Parlin, New Jersey 08859 for a total contract amount of \$115,150.00; and

WHEREAS, the bid documents submitted by S. Batata Construction, 238 Ernston Road, Suite 1R, Parlin, New Jersey 08859 were found to be complete; and

WHEREAS, it is the recommendation of the Township Engineer that the contract be awarded to the low bidder, S. Batata Construction, 238 Ernston Road, Suite 1R, Parlin, New Jersey 08859 for a total contract amount of \$115,150.00; and

WHEREAS, the Director of Finance has indicated that funding is available in Township Capital Account # C-04-55-874-966 and C-04-55-873-965.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above sidewalk repair program with S. Batata Construction, 238 Ernston Road, Suite 1R, Parlin, New Jersey 08859 for a total contract amount of \$115,150.00.
