**2014 RESOLUTION CHANGE ORDERS**

**JOHN F. KENNEDY ROADWAY IMPROVEMENTS - PHASE 1 - CHANGE ORDER  
NO. 1- FINAL**

**WHEREAS**, the Township of Bloomfield entered into a contract for the John F. Kennedy Drive Roadway Improvements - Phase 1 with AJM Contractors, Inc. 300 Kuller Road, Clifton, New Jersey 07011 (hereinafter "the Contractor"); and

**WHEREAS**, during the course of construction, unforeseen, site conditions were encountered, which required modifications to the scope of work; and

**WHEREAS**, the Township Engineer has reviewed the changes enumerated in Change Order No. 1 - Final and recommends the Change Order be approved; and

**WHEREAS**, Change Order No. 1 - Final represents an decrease in the contract cost in the amount of \$34,476.50 or 13.6%; and

**WHEREAS**, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the specified changes should be approved; and

**WHEREAS**, this Change Order was found to be beneficial and necessary.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final, is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
