**2014 RESOLUTION APPROVAL**

**OFFICE OF EMERGENCY MANAGEMENT PHONE UPGRADE**

**WHEREAS**, Bloomfield Office of Emergency Management is responsible for activating the Emergency Operations Center in the event of a declared emergency in the Township; and

**WHEREAS**, the Emergency Operations Center maintains a telephone system which combines the use of direct telephone lines on the Township system. These are the lines citizens utilize when calling during an incident; and

**WHEREAS**, the Township changed its telephone system to a new state-of-the-art VOIP system; and

**WHEREAS**, the Township needed to make adjustments so the systems could be compatible; unfortunately, these adjustments did not work efficiently for our system; and

**WHEREAS**, Office Solutions provided a quote to the Township to replace the current OEM System with a new compatible system that works with VOIP system for \$5,700.00; and

**WHEREAS**, the Director of Technology has determined that the value of these services will benefit the Township; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of these services.

**NOW, THEREFORE, BE RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, authorizes the Director of Technology to enter into a state contract with Office Solutions.
