**WHEREAS**, under N.J.S.A. 54:4-99 a governing body of a municipality may abate or cancel any taxes as it shall deem equitable and just and be for the best interest of the municipality; and

**WHEREAS**, certain 2014 taxes and water charges remain outstanding on the township of Bloomfield tax records; and
