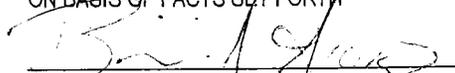

**ADDENDUM TO THE 2013-2016 AGREEMENT
BETWEEN THE TOWNSHIP AND PBA LOCAL 32**

WHEREAS, the Township and the PBA are parties to an agreement that expired on December 31, 2012; and

WHEREAS, on or about May 19, 2014, both parties signed a successor agreement which is effective from January 1, 2013 through December 31, 2016 (2013 Agreement); and

WHEREAS, after both parties signed the 2013 Agreement, they discovered a clerical error in the language under the salary guide on page 46 which needed to be corrected;

NOW THEREFORE BE IT RESOLVED that the parties hereby agree to amend the 2013 Agreement as follows:

1. The following sentence immediately underneath the salary guide in Article XXIII on page 46 shall be deleted: "It is understood that the holiday pay and adjusted pay is to be utilized for pension calculations only, and for no other purposes (see Article IX-D and E)" and shall be replaced with the following sentence: "Holiday pay shall not be used in computation of overtime, pay for work in higher rank, terminal leave or any other fringe benefit (see Article IX-C and D)."
2. All other provisions of the 2013 Agreement shall remain in full force and effect.

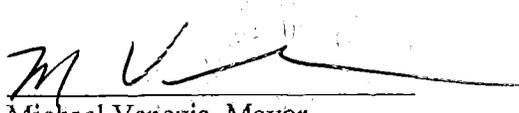

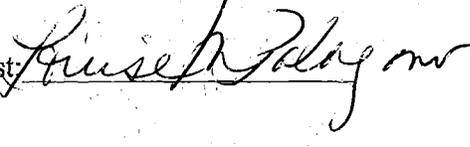
