2014 RESOLUTION AWARD OF CONTRACT

**AWARD OF CONTRACT - BLOOMFIELD CENTER INTERSECTION
IMPROVEMENTS (SIX-POINTS INTERSECTION) FEDERAL PROJECT NUMBER
TCP-7672(123) CON**

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on September 3, 2014 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for Bloomfield Center Intersection Improvements (Six-Points Intersection) Federal Project Number TCP-7672(123) CON; and

WHEREAS, a total of two (2) bids were received and were referred to the Project Design Consultant and the Township Engineer for review; and

WHEREAS, the low bidder was AJM Contractors, Inc., 300 Kuller Road, Clifton, New Jersey with a base bid in the amount of \$1,554,439.00; and

WHEREAS, funding for this project will be allocated from the following sources:

WHEREAS, the Director of Finance has indicated that funding is available in the Township's Capital Roadway Program and the Township Community Development Block Grant Funds.
