2014 RESOLUTION AWARD OF CONTRACT

AWARD OF AN EMERGENCY REPAIR CONTRACT FOR REPLACEMENT OF THE HALCYON PARK FOUNTAIN WALL

WHEREAS, on or about August 31, 2014, heavy rainfall and stormwater in Halcyon Park resulted in the collapse of a wall that borders the Halcyon Park Fountain; and

WHEREAS, the loss of this wall now creates a hazard to the general public in that there is no permanent barrier from the walkway to the edge of the pond; and

WHEREAS, failure to remedy this situation on an emergent basis will result in a continued, potential hazard to the general public as well as the potential for continued undermining of the sidewalk adjacent to the pond; and

WHEREAS, the firm, Tec Con Contractors, Inc., 9 Dodd Street, East Orange, New Jersey 07017, provided a proposal in the amount of \$16,500.00 to replace approximately 100 linear feet of the collapsed wall; and

WHEREAS, after review of the proposal, as well as an on-site meeting with representatives of Tec Con, Contractors, Inc., it is the Township Engineer's recommendation that the contract be awarded to Tec Con Contractor's Inc., in an amount not to exceed \$16,500.00; and

WHEREAS, it is in the best interest of the Township of Bloomfield, on behalf of the general public to have the wall replaced on an emergent basis; and

WHEREAS, the Director of Finance has indicated that funding is available in the Township's Capital Engineering & Building s and Grounds Account C-04-55-877-947.

NOW, BE IT RESOLVED, by the Mayor and Township Council of the Township of Bloomfield, County of Essex, State of New Jersey that the contract to replace the damaged wall
