AWARD OF CONTRACT FOR DISPOSAL OF VEGETATIVE WASTE

WHEREAS, sealed bids were received by the Purchasing Committee of the Township of Bloomfield for hauling and disposal of vegetative waste, on August 17, 2014 in the Council Chambers of the Municipal Building, Bloomfield, New Jersey; and

WHEREAS, two bids were received from the following:

Item 1 - Furnish appropriate trucks, containers and drivers to remove soft vegetative waste, brush and tree parts loaded by township employees at 230 Grove Street. 7,000 CY @ \$17.95 = \$ 125,650.00

Item 2 - Furnish appropriate trucks, containers and drivers to remove leaves loaded by township employees at 230 Grove Street. 5,000 CY @ \$12.45 = \$ 64,750.00

Item 3 - Furnish appropriate trucks, containers and drivers to remove leaves loaded by township employees at a location other than 230 Grove Street. 5,000 CY @ \$20.95 = \$ 104,750.00

Item 3 - Furnish appropriate trucks, containers and drivers to remove leaves loaded by township employees at a location other than 230 Grove Street. 5,000 CY @ \$13.95 = \$ 69,750.00

TOTAL ITEMS 1, 2 & 3: **\$271,800.00 ; and**

WHEREAS, all bids were referred to the Township Engineer; and

WHEREAS, the bid proposals indicate that award of the bid should be based upon the sum of Items 1 and 2; and

WHEREAS, the Township Engineer after due consideration the bid recommends that the contract be awarded to Global Development Contractors, 86 Lavergne Street, Belleville, New Jersey 07109 at the unit prices for Items 1 and 2 above for a total amount not to exceed \$190,400.00; and

WHEREAS, the Director of Finance has indicated that funding is available within the operating budget of the Department of Public Works.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that in accordance with the recommendation of the Township Engineer that the contract for hauling and disposal of

vegetative waste is hereby awarded to Global Development Contractors, 86 Lavergne Street, Belleville, New Jersey 07109 for the unit prices for Items 1 and 2 above for a total amount not to exceed \$190,400.00.
