**2014 RESOLUTION LEASE/PURCHASE AGREEMENTS**

**PURCHASE OF VEHICLES, POLICE DEPARTMENT**

**WHEREAS**, the Director of Police has requested that the Township purchase four Marked Ford Police Interceptor SUV's and two unmarked Ford Police Interceptors for the Bloomfield Police Department; and

**WHEREAS**, the above described vehicles can be purchased under the Morris County CO-OP Contract #15A item's 1A & 3 from Beyer Ford Fleet & Leasing, 170 Ridgedale Avenue, Morristown, NJ 07936; and

**WHEREAS**, Beyer Ford Fleet Leasing, has submitted a proposal to sell four marked Ford Police Interceptor SUV's to the Bloomfield Police Department at a cost of \$35,218.75 per vehicle and one unmarked Ford Interceptor Police SUV at a cost of \$30,003.75 and one unmarked Ford Interceptor Sedan at the cost of \$29,839.75 which can be paid for by making three annual payments of \$70,506.23; and

**WHEREAS**, the Director of Finance has certified funds are available in the Operating budget.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor is authorized to sign and the Clerk to attest an agreement to purchase the six 2015 Ford Police Interceptor Vehicles from Beyer Ford Fleet & Leasing, 170 Ridgedale Avenue, Morristown, NJ 07936 at a total cost of \$200,718.00.
