2014 RESOLUTION AWARD OF CONTRACT

**AWARD OF CONTRACT FOR REPLACEMENT OF A STORM SEWER LINE
BETWEEN BURROUGHS PLACE AND JOHN F. KENNEDY DRIVE SOUTH**

WHEREAS, extensive flooding has been occurring within the properties along Burroughs Place between Burroughs Place and John F. Kennedy Drive South during the past several heavy rainfalls; and

WHEREAS, this flooding has not been observed to be a normal occurrence for this area during these types of rainfall events over the past several years; and

WHEREAS, this flooding has resulted in damage to properties as well as representing an issue of public safety; and

WHEREAS, a camera inspection of the sewer line by the Bloomfield Engineering Department revealed a collapse in the sewer line which was determined to be the cause of the flooding; and

WHEREAS, the Engineering Department solicited two prices to replace the broken line with the lowest price being provided by John Garcia Construction, Inc., 183 Friar Lane, Clifton, New Jersey 07013 in the amount of \$16,433.50; and

WHEREAS, it is in the best interest of the Township of Bloomfield, on behalf of general public safety to have the sewer line replaced; and

WHEREAS, it is the recommendation of the Township Engineer that the sewer line be replaced expeditiously and that the contract be awarded to John Garcia Construction, Inc., 183 Friar Lane, Clifton, New Jersey 07013 in the amount of \$16,433.50; and

WHEREAS, the Director of Finance has indicated that funding is available in the Township's Capital Sewer Account C-04-55-853-987.
