2014 RESOLUTION AUTHORIZATIONS

RESOLUTION FOR THE EXECUTION OF AN APPLICATION FOR A NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION TREATMENT WORKS APPROVAL - PUBLIC SERVICE ELECTRIC AND GAS COMPANY (PSE&G) BRANCH BROOK SUBSTATION, BLOCK 391; LOT 66 & 67

WHEREAS, Public Service Electric and Gas Company (PSE&G), 400 Hadley Road, South Plainfield, New Jersey, hereafter referred to as "the Applicant" is proposing the construction an upgraded electrical substation on Block 391, Lot 66 and 67 in the Township of Bloomfield which will also include the construction of a groundwater treatment facility; and

WHEREAS, the construction of the groundwater treatment facility will require the submission of a Treatment Works Approval Application to the New Jersey Department of Environmental Protection; and

WHEREAS, a Treatment Works Approval application requires execution of a Statement of Consent (Form WQM-003) by the governing body in which the project is located and into whose facility the groundwater will discharge, which is the Township of Bloomfield; and

WHEREAS, the plans and application materials were reviewed and approved by the Township Engineer and were found to be acceptable.

NOW, BE IT RESOLVED, by the Mayor and Township Council that the Mayor of the Township of Bloomfield is hereby authorized to execute the Statement of Consent (Form WQM-003) and any other required documents for submission of a New Jersey Department of Environmental Protection Treatment Works Approval for the construction of a groundwater treatment facility on Block 391, Lot 66 and 67 in the Township of Bloomfield.
