2014 RESOLUTION CHANGE ORDERS

**2014 RESOLUTION - 2013 CATCH BASIN AND MANHOLE UPGRADE PROGRAM -
CHANGE ORDER NO. 1 - FINAL**

WHEREAS, the Township of Bloomfield entered into a contract for the 2013 Catch Basin And Manhole Upgrade Program with John Garcia Construction Company, Inc., 183 Friars Lane, Clifton, New Jersey 07103 for the unit prices given to an amount not to exceed \$40,000.00 (hereinafter "the Contractor"); and

WHEREAS, during the course of construction, additional structures were found to require upgrading; and

WHEREAS, the contractor provided a cost proposal to upgrade the additional structures at a cost of \$7,895.00; and

WHEREAS, the Township Engineer has reviewed cost associated with Change Order No. 1 and recommends the Change Order be approved; and

WHEREAS, Change Order No. 1 represents an increase in the cost of the contract in the amount of 19.7%; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the Change Order should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Capital Account #C-04-55-830-987 and. #C-04-55-863-987.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust
