2014 AUTHORIZING RESOLUTION FOR THE EXECUTION OF AN APPLICATION FOR A NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION TREATMENT WORKS APPROVAL - THE GREEN AT BLOOMFIELD - BLOCK 243; LOTS 13, 25, 27, 28, 30, 31, 32,37 & 38

WHEREAS, MCP Bloomfield Urban Renewal LLC, 12 Vreeland Avenue, Totowa, NJ 07512 is proposing the construction 140 residential apartment units and approximately 11,530 square feet of retail space on Block 243; Lots 13, 25, 27, 28, 30, 31, 32,37 & 38, in the Township of Bloomfield which will also include the construction of approximately 256 linear feet of 8-inch diameter sanitary sewer; and

WHEREAS, the construction of the sanitary sewer will require the submission of a Treatment Works Approval Application to the New Jersey Department of Environmental Protection; and

WHEREAS, a Treatment Works Approval application requires execution of a New Jersey Department of Environmental Protection, Treatment Works Application and Statement of Consent (Form WQM-003) by the governing body in which the project is; and

WHEREAS, the plans and application materials were reviewed and approved by the Township Engineer and were found to be acceptable.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Council that the Mayor of the Township of Bloomfield is hereby authorized to execute the Treatment Works Application and Statement of Consent (Form WQM-003) as well as any other required documents for submission of a New Jersey Department of Environmental Protection Treatment
