2014 RESOLUTION APPROVAL

RESOLUTION - FELICITY TOWER

WHEREAS, on or about September 1972, the Township Council for the Township of Bloomfield (the "Township") a passed Resolution, which authorized the execution of an agreement (the "Agreement") between the Township and the Bloomfield Citizens Housing Corporation/Felicity Towers ("Bloomfield Senior"), a non-profit corporation of the State of New Jersey, whereby Bloomfield Senior would make payments in lieu of taxes ("PILOT") for the housing complex to be constructed and ultimately named the Felicity Towers (the "Felicity Towers"); and

WHEREAS, the Agreement, provides that for the duration of the PILOT Period, Bloomfield Senior shall pay to the Township, in lieu of taxes and on a quarterly basis, the sum of fifteen-percent (15%) of its annual gross shelter rent; and

WHEREAS, Bloomfield Senior is presently negotiating to refinance the mortgage for Felicity Towers, and for that purpose requires assurances of the Township's intent to adhere to the terms of the Agreement, and more specifically to continue to permit PILOT for the Bloomfield Senior during the remainder of the PILOT Period; and

WHEREAS, the Township intends to adhere to the terms of the Agreement, and to continue to permit PILOT for the Bloomfield Senior during the remainder of the PILOT Period;

NOW, BE IT HEREBY RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BLOOMFIELD, that the Township will adhere to the terms of the Agreement, and will continue to permit PILOT for the Bloomfield Senior during the remainder of the PILOT Period; and

BE IT FURTHER RESOLVED, that this Resolution shall be published and made available in the Clerk's Office for reasonable inspection in accordance with applicable law.
