**2014 RESOLUTION AUTHORIZATIONS**

**AUTHORIZING RESOLUTION FOR THE BLOOMFIELD AVENUE INTERSECTION IMPROVEMENTS (SIX- POINTS PROJECT) - FEDERAL PROJECT NO. TCP-7672(123) CON - AMENDED**

WHEREAS, the Township of Bloomfield has been awarded a grant in the amount of \$847,860.00 through the Federal Highway Administration (FHWA) for the Bloomfield Avenue Intersection Improvements also known as the "Six-Points Improvement Project" within the Township of Bloomfield; and

WHEREAS, cost reimbursement to the Township will be accomplished through Federal Aid Agreement No. 2014-DT-BLA-207 between the Township of Bloomfield and the New Jersey Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield:

1. That Mayor Michael J. Venezia or the successor to the Office of the Mayor of the Township of Bloomfield is hereby authorized to execute an agreement and any amendment thereto with the New Jersey Department of Transportation for the project known as Bloomfield Avenue Intersection Improvements, and
2. The Township of Bloomfield agrees to comply with all applicable federal, state and local laws, rules and regulations in its performance of the project, and
3. This resolution shall take effect immediately.
