2014 RESOLUTION CHANGE ORDERS

ROOF REPLACEMENT AT BLOOMFIELD FIRE HEADQUARTERS - CHANGE ORDER NO. 1 - FINAL

WHEREAS, the Township of Bloomfield entered into a contract for the replacement of the roof at the Bloomfield Township Fire Headquarters with Build Rite, LLC, 16 Darlington Drive, Wayne, New Jersey 07470 (hereinafter "the contractor"); and

WHEREAS, during the course of the project, as certain rooftop features were uncovered and inspected, changes to the project scope were required; and

WHEREAS, the changes resulted in a net decrease to the contract price of \$33,500.00 thereby resulting in a final contract price of \$116,400.00; and

WHEREAS, the Township Engineer has reviewed the changes and recommends that they be accepted; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the specified changes should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
