**2014 RESOLUTION APPOINTMENT**

**EMERGENCY MEDICAL DISPATCHER/TELECOMMUNICATOR**

**WHEREAS**, Director DeMaio recommends that Alphonse A. Caruso of Bloomfield be appointed to the position of Emergency Medical Dispatcher/Telecommunicator effective December 2, 2014; and

**WHEREAS**, the Director of Finance has certified that funding is available for this position in the Police Department Budget.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Alphonse A. Caruso is hereby appointed to the position of Emergency Medical Dispatcher/Telecommunicator for the Bloomfield Police Department, effective December 2, 2014, at step 8 of the negotiated salary contained in the Collective Bargaining Agreement in effect for such position; and

**BE IT FURTHER RESOLVED**, that this appointment is subject to the Bloomfield Township Town Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield and to maintain such a residency and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharged from employment.
