2014 RESOLUTION APPOINTMENT

EMERGENCY MEDICAL DISPATCHER/TELECOMMUNICATOR

WHEREAS, Director DeMaio recommends that Michael Spinella of Clifton be appointed to the position of Emergency Medical Dispatcher/Telecommunicator effective December 2, 2014; and

WHEREAS, the Director of Finance has certified that funding is available for this position in the Police Department Budget.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Michael Spinella is hereby appointed to the position of Emergency Medical Dispatcher/Telecommunicator for the Bloomfield Police Department, effective December 2, 2014, at step 8 of the negotiated salary contained in the Collective Bargaining Agreement in effect for such position; and

BE IT FURTHER RESOLVED, that this appointment is subject to the Bloomfield Township Town Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield and to maintain such a residency and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharged from employment; and

BE IT FURTHER RESOLVED, that Michael Spinella must become a resident of the Township of Bloomfield as required by the Township's Code on or before December 2, 2015 or his employment shall cease without further action of the Council.
