2014 RESOLUTION APPROVAL

RESOLUTION - AUTHORIZING DISPOSAL OF SURPLUS PROPERTY

WHEREAS, the Bloomfield Fire Department is the owner of certain surplus property which is no longer needed for public use; and

WHEREAS, the Fire Department are desirous of selling said surplus property in an "as is" condition without express or implied warranties.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

(1) The sale of the surplus property shall be conducted through GovDeals pursuant to State Contract A-83453/T2581 in accordance with the terms and conditions of the State Contract. The terms and conditions of the agreement entered into with GovDeals is available online at govdeals.com and also available from the Bloomfield Fire Department.

(2) The sale will be conducted online and the address of the auction site is govdeals.com.

(3) The sale is being conducted pursuant to Local Finance Notice 2008-9.

(4) A list of the surplus property to be sold is as follows: 1996 E-One Eagle, VIN #4ENBAAA89T100637 and the odometer reading is 13,800.

(5) The surplus property as identified shall be sold in an "as-is" condition without express or implied warranties with the successful bidder required to execute a Hold Harmless and Indemnification Agreement concerning use of said surplus property.

(6) The Fire Department reserves the right to accept or reject any bid submitted.
