2014 RESOLUTION AWARD OF CONTRACT

REPLACEMENT OF ROOF AT BLOOMFIELD LAW ENFORCEMENT BUILDING

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on November 13, 2014 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the replacement of the roof at the Bloomfield Township Law Enforcement Building; and

WHEREAS, a total of seven (7) bids were received and were referred to the Township Engineer and Engineering Consultant for review; and

WHEREAS, the responsive, low bidder was determined to be Northeast Roof Maintenance, 649 Catherine Street, Perth Amboy, New Jersey 08861 in the amount of \$158,150.00; and

WHEREAS, after review of the bids, and upon recommendation by the project consultant, Remington & Vernick Engineers the Township Engineer hereby recommends that the contract be awarded to the lowest, responsive bidder Northeast Roof Maintenance, 649 Catherine Street, Perth Amboy, New Jersey 08861 in the amount of \$158,150.00; and

WHEREAS, the Director of Finance has indicated that funding is available within Township Capital Account #C-04-55-877-947.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above work with Northeast Roof Maintenance, 649 Catherine Street, Perth Amboy, New Jersey 08861 in the
