**2013 RESOLUTION CHANGE ORDERS**

**CHILDREN'S LIBRARY HEATING REPAIRS &  
REPLACEMENT – CHANGE ORDER NO. 1 – ADDITIONAL  
CONCRETE FLOOR & WALL REPAIRS**

WHEREAS, the Township of Bloomfield entered into a contract for the repair and upgrade of the Bloomfield Children's Library Heating System with C. Dougherty and Company, (hereinafter "the contractor"), 7 Washington Avenue, Paterson, New Jersey 07503 in the amount of \$350,750.00; and

WHEREAS, there were pre-existing conditions unrelated to the current project that were recommended to be incorporated into this contract by the project consultant, Maser Consulting, P.A.; and

WHEREAS, these unrelated conditions were recommended for inclusion in the current project to mitigate an unsafe condition for individuals utilizing the Children's Library; and

WHEREAS, this work is related to filling and sealing utility trenches and openings within the floor and walls of the Children's Library; and

WHEREAS, the contractor has provided a price of \$5,800.00 to perform this additional work; and

WHEREAS, the Township Engineer has reviewed the scope of this work and agrees with the Project Consultant that this Change Order be approved; and

WHEREAS, Change Order No. 1 represents an increase in the contract of 1.7% (percent); and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the specified changes should be approved; and
