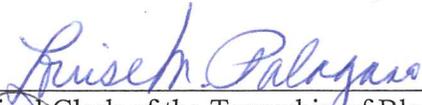

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of these services through the Township's Open Space Trust Fund account.

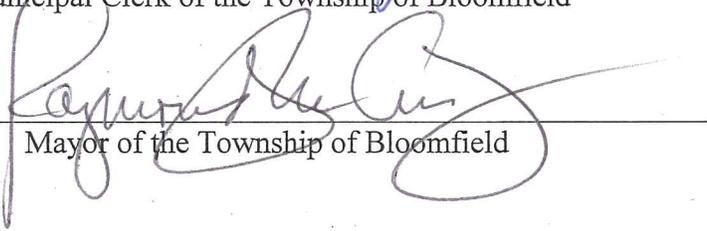
