2013 RESOLUTION AWARD OF CONTRACT

ELEVATOR MAINTENANCE MUNICIPALLY-OWNED BUILDINGS

WHEREAS, informal bids were received by the Engineering Department for a one-year contract for maintenance of the elevators within the Municipal Building, Law Enforcement Building and Civic Center in accordance with the applicable requirements of N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for Elevator Maintenance of Municipally-Owned Buildings; and

WHEREAS, after review of the bids submitted, the Township Engineer hereby recommends that the contract be awarded to the lowest responsible bidder, Arrow Elevator Incorporated, 4 Cecilia Court, Vernon, New Jersey in the amount of \$3,780.00; and

WHEREAS, the Director of Finance has indicated that funding is available under Municipal Account No. 3-01-26-772-024.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for elevator maintenance with Arrow Elevator Incorporated, 4 Cecilia Court, Vernon, New Jersey 07462 in the amount of \$3,780.00.
