**2013 RESOLUTION AWARD OF CONTRACT**

**CODE RED SERVICE AGREEMENT**

**WHEREAS**, the Director of Information Systems recommends the Township of Bloomfield enter into a contract with Emergency Communications Network (ECN) to provide Emergency Communication Network Services to the Township; and

**WHEREAS**, the contract shall not exceed the bid threshold; and

**WHEREAS**, this service will provide the Township with 62,500 minutes of Emergency Communication Notification services that the Township anticipates on sharing with the Board of Education and with unlimited Emergency system minutes; and


**WHEREAS**, the Director of Finance has indicated that funding is available for these services.


