WHEREAS, the Township of Bloomfield desires to enter into an agreement with the Board of Education to provide the Board of Education with Emergency Communication services; and

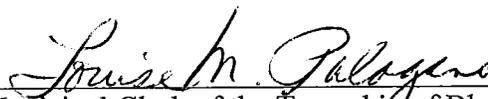
WHEREAS, under the agreement the Township and the Board of Education will share 62,500 minutes of Emergency Communication Services and unlimited Emergency system minutes; and

WHEREAS, the Board of Education will pay the Township \$13,451 for access to the Emergency Communication Services.

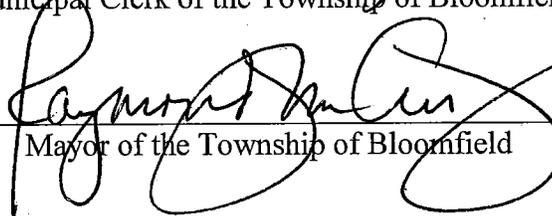
