THE EXECUTION OF AN APPLICATION FOR A NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION WATER SUPPLY APPLICATION - AVB BLOOMFIELD STATION URBAN RENEWAL - BLOCK 228

WHEREAS, AVB Bloomfield Station Urban Renewal, LLC, 517 Route 1 South, Suite 5500, Woodbridge, New Jersey 08830, hereafter referred to as "the Applicant" is proposing the construction of a mixed commercial and residential development consisting of 224 residential units; and

WHEREAS, this development will require the submission of an application to Construct/Modify/Operate a Public Water Works Facility Or State Certification of Fifty or More Realty Improvements to the New Jersey Department of Environmental Protection; and

WHEREAS, this application requires execution of a standard application, PA-01; PA05E and PA10 by the governing body or its designated representative in which the project is located which is the Township of Bloomfield; and

WHEREAS, the plans and application materials were reviewed and approved by the Township Engineer and were found to be acceptable.

NOW, BE IT RESOLVED, by the Mayor and Council that the Mayor of the Township of Bloomfield, County of Essex, State of New Jersey and his designated representative, Anthony Marucci, the Township's Water Operator are hereby authorized to execute Forms PA-01; PA05E and PA10 and any other required documents for submission of a New Jersey Department of Environmental Protection Water Supply Application for the construction of a mixed, commercial and residential development consisting of 224 residential units on Block 228.
