EXECUTION OF AN APPLICATION FOR A NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION TREATMENT WORKS APPROVAL - OAKS POND REDEVELOPMENT, BLOCK 544, LOTS 40 & 61, 221-225 BELLEVILLE AVENUE

WHEREAS, Bloomfield-Belleville Associates, 820 Morris Turnpike, Short Hills, New Jersey 07078 hereafter referred to as "the Applicant" is proposing the construction of a residential apartment development, as well as 963 linear feet of 8-inch diameter sanitary sewer; and

WHEREAS, this development will require the submission of a Treatment Works Approval Application to the New Jersey Department of Environmental Protection; and

WHEREAS, a Treatment Works Approval application requires execution of a Statement of Consent (Form WQM-003) by the governing body in which the project is located which is the Township of Bloomfield; and

WHEREAS, the plans and application materials were reviewed and approved by the Township Engineer and were found to be acceptable.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Council that the Mayor of the Township of Bloomfield is hereby authorized to execute the Statement of Consent (Form WQM-003) and any other required documents for submission of a New Jersey Department of Environmental Protection Treatment Works Approval for the redevelopment of Block 228 in the Township of Bloomfield.
