2013 RESOLUTION AWARD OF CONTRACT

2010 - 2011 CAPITAL ROADWAY & TRAFFIC CALMING PROGRAM

WHEREAS, a total of seven (7) bids were received and were referred to the Township Engineer for review; and

WHEREAS, the Director of Finance has indicated that funding is available in the Township's Capital Roadway Program Account Numbers C-04-55-850-965, C-04-55-851-966 & C-04-55-862-966.

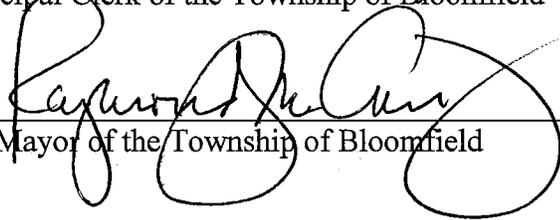
