RESOLUTION OF THE MAYOR AND TOWNSHIP COUNCIL OF THE TOWNSHIP OF BLOOMFIELD IN THE COUNTY OF ESSEX AUTHORIZING SETTLEMENT OF THE 2012 TAX APPEAL ENTITLED ANNA LEVIN V. TOWNSHIP OF BLOOMFIELD, DOCKET NO.: 014056-2012 OF THE TAX ASSESSMENT OF BLOCK 919, LOT 13 KNOWN AS 32 KETNER STREET, IN THE TOWNSHIP OF BLOOMFIELD, ESSEX COUNTY, NEW JERSEY

1. Settlement of the 2012 tax appeal is hereby authorized as follows:


