AUTHORIZING SUBMISSION OF APPLICATION FOR TOGETHER NORTH JERSEY LOCAL DEMONSTRATION PROJECT GRANT

WHEREAS, the Mayor and Council of the Township of Bloomfield desire to apply for and obtain a Together North Jersey Local Demonstration Project Program grant from the North Jersey Sustainable Communities Consortium; and

WHEREAS, the scope of the proposed project is to prepare a Complete Streets Corridor Plan for Bloomfield Avenue that will evaluate the Bloomfield Avenue corridor from the Garden State Parkway in Bloomfield to Verona to determine its ability to incorporate complete streets design concepts; and

WHEREAS, in order to obtain such a grant, it is necessary that the participating municipalities submit a resolution in support of the application which is due on April 8, 2013; and

WHEREAS, the Township will leverage its resources to complete the project through the provision of in-kind services and technical assistance; and

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield that it fully supports the grant application; and

BE IT FURTHER RESOLVED, that the Mayor and the Township Administrator are hereby authorized and directed to execute any and all documents necessary for the submission and completion of such an application on behalf of the Township of Bloomfield.
