2013 RESOLUTION ABC TRANSFERS

PLENARY RETAIL CONSUMPTION LICENSE

WHEREAS, an application has been filed for a person-to-person transfer of Plenary Retail Consumption License 0702-33-036-011, heretofore issued to Los Andes Enterprises, LLC for premises located at 418 Broad Street, Bloomfield, NJ 07003; and

WHEREAS, the submitted application form is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term; and
